

**BRACKNELL FOREST BOROUGH COUNCIL**  
**(BINFIELD 10k ROAD RACE) (TEMPORARY ROAD CLOSURES) ORDER 2024**

**WHEREAS** the Bracknell Forest Borough Council (hereinafter referred to as “the Council”), as the Traffic Authority for the roads specified in the Schedule hereto (“the Roads”) are satisfied that:

- (a) traffic on the Roads specified in the Schedule hereto should be restricted and/or prohibited for the purpose of facilitating the holding of 10km road race.

**NOW THEREFORE THE COUNCIL**, in exercise of their powers under Sections 16A, 16B and 16C of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994) make the following Order:


1. The following Regulations shall be observed between 12.01am and 11.59pm on Sunday 19<sup>th</sup> May 2024 as determined by any Police Officer in uniform, or any person duly authorised by the Council.
2. No person shall allow any vehicle except (a) upon permission of a Police Officer in uniform or (b) upon permission of any person duly authorised by the Council or (c) which is being used on an official basis in connection with the holding of the said 10km road race to enter the roads referred to in the Schedule hereto between 12.01am and 11.59pm on Sunday 19<sup>th</sup> May 2024.
3. This Order is made under Section 16A, 16B and 16C of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994).
4. This Order shall only apply when the appropriate signs are displayed in the Road.
5. This Order may be cited as “Bracknell Forest Borough Council (Binfield 10k Road Race) (Temporary Road Closures) Order 2024”.

## SCHEDULE

- (i) Benefield Road for its whole length;
- (ii) B3034 Forest Road between its junctions with Benefield Road and Terrace Road South;
- (iii) Wicks Green for its entire length;
- (iv) B3018 Church Hill / Twyford Road between its junctions with Terrace Road North and Howe Lane;
- (v) Howe Lane between its junctions with B3018 Twyford Road and Bottle Lane;
- (vi) Bottle Lane for its whole length;
- (vii) Ryehurst Lane for its whole length;
- (viii) Stubbs Hill for its whole length;
- (ix) Terrace Road North between its junctions with Tilehurst Lane and B3018 Church Lane;
- (x) Northbound traffic on Terrace Road South between its junctions with Foxley Lane and B3034 Forest Road;
